### Technical expertise

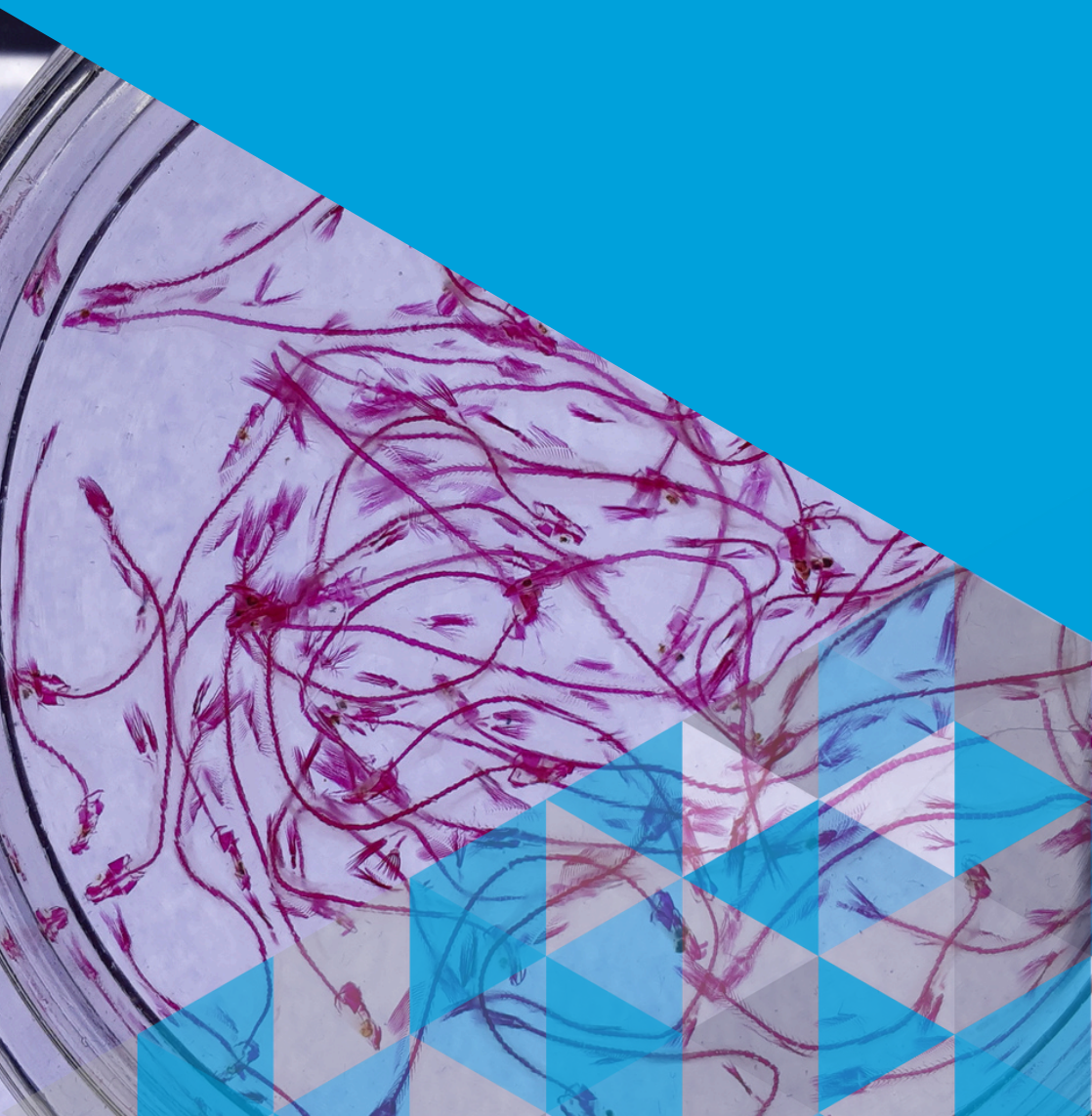
